# Global Alliance for Information and Communication Technologies and Development

The Global Alliance for Information and Communication Technologies and Development (GAID) was created by the Secretary-General of the United Nations in March 2006, and launched in Kuala Lumpur on 19-20 June 2006. Since assuming the office of Secretary-General on 1 January 2007, Mr. Ban Ki-Moon has identified information and communication technologies (ICT) as a priority area for the United Nations in support of the goals of the Global Alliance. Having been involved in the field for years, Mr. Ban sees ICT as powerful tools to further development, and he encourages the use of the United Nations' convening power to bring together information and communication technologies for development (ICTD) actors to contribute to the attainment of a development-oriented, people-centred, inclusive Information Society and to further the United Nations development goals.

In this Inaugural year, GAID's energies have focused on (a) developing and operationalizing an appropriate organizational structure, (b) defining its areas of priority and developing its business plan, (c) building collaborative links and (d) raising awareness of the Alliance.

The Alliance was supported through 2006 by a light secretariat based in New York, composed of an Executive Coordinator, three project staff, a staff member seconded from the Ministry of Science, Technology and Innovation of Malaysia, one consultant and three staff temporarily seconded on a part-time basis from the United Nations Department of Economic and Social Affairs.

GAID has laid a firm foundation for future activities having (i) established its governance mechanisms; (ii) agreed its mission and objectives; (iii) approved its areas of focus and a business plan for 2006-2007; (iv) begun forming the organizational framework for partnerships through which the Alliance aims to leverage the resources, know-how, energy and will of various stakeholders to meet its objectives; (v) organized several successful meetings and engaged in other outreach activities; and (vi) undertaken preparations for planned 2007 activities. The report concludes with (vii) a brief assessment of GAID's progress.

# (i) Governance and advisory mechanisms

The Global Alliance was established on the basis of the principles and elements<sup>1</sup> that emerged following one-and-a-half years of international, multi-stakeholder consultation undertaken by the United Nations ICT Task Force<sup>2</sup>. In the second quarter of 2006, nominations for the GAID **Strategy Council** were solicited, and the 60-member Council<sup>3</sup> composed of 30

governments and 30 representatives from the private sector, civil society and international organizations was formed to provide strategic guidance and vision for the Alliance. An 11member Steering Committee<sup>4</sup>, led by Chairman Craig Barrett, Chairman of the Board of Intel Corporation, was also formed to provide executive direction to. and priority setting for the Alliance, as well as oversight and guidance to the secretariat.

A panel of **High-level Advisers**<sup>5</sup> has been constituted, providing a pool of policy and expert advice to the Global Alliance, and the GAID Network of **Champions**<sup>6</sup> is a growing group of practitioners, experts and activists who facilitates the diffusion of knowledge and experience of innovative uses of ICT for the attainment of development goals, provides "bottom-up" flow of information on implementation of ICTD activities on the ground to inform policy discussions at the Global Forum and in the Steering Committee and the Strategy Council, and promotes the implementation of the Alliance's outreach efforts, as well as fosters formation of partnerships. Both networks are connected through web-based groups, maintained by the secretariat.

#### Mission and objectives (ii)

Under the guidance of the Chair and with input from the Steering Committee and the Strategy Council, the mission of the Global Alliance for ICT and Development was agreed:

to contribute to transforming the spirit and vision of the World Summit on the Information Society (WSIS) into action and promoting the use of ICT for the achievement of the internationally agreed development goals, including the Millennium Development Goals (MDGs).

The Alliance works toward fulfilling this mission by providing an inclusive, multistakeholder global forum and platform for cross-sectoral policy dialogue and advocacy and by catalyzing multi-stakeholder, action-oriented partnerships encouraged under the GAID umbrella. In itself, GAID does not have any operational or implementing role. It provides multistakeholder input to intergovernmental bodies, including the Economic and Social Council and the Commission for Science and Technology for Development.

Six broad objectives that support its mission and will be pursued over its lifetime have been identified:

- Mainstreaming the global ICT agenda into the broader United Nations Development Agenda;
- Bringing together key organizations and other stakeholders involved in ICT for development to enhance their collaboration and effectiveness for achieving the internationally agreed development goals;
- Raising awareness of policy makers on ICTD policy issues;
- Facilitating identification of technological solutions for specific development needs and goals and launching of pertinent partnerships;

- Promoting creation of an enabling environment and innovative business models for pro-poor investment, innovation and entrepreneurship and growth and for empowering people living in poverty and other marginalized communities; and
- Providing the Secretary-General with advice on ICTD-related issues.

# (iii) Areas of focus and business plan

The Strategy Council of the Global Alliance decided at its first meeting in Kuala Lumpur (see Section v below) that GAID will initially focus on the use of ICT in promoting the following **four focus areas**: (1) education, (2) health, (3) entrepreneurship, and (4) governance (specifically, enhancing citizens' participation and promoting accountability, transparency and efficiency in governance processes).

A High-level meeting of the Steering Committee was convened under the Chairmanship of Craig Barrett at the United Nations Headquarters on 27 September 2006 (see Section v below), to discuss the draft **business plan,** which would provide direction and a framework for the work of the Global Alliance through its first year. The Steering Committee approved the business plan in December 2006, at which time it was made publicly available.

# (iv) Framework for partnership

In order to take concrete steps toward achieving these objectives, through the collaborative efforts of the Chair, the secretariat, the Steering Committee, Strategy Council and other partners, the Global Alliance is creating a framework to foster policy debate and partnerships-for-action, as laid out in the business plan. The framework is composed of multiple networks operating for different purposes and goals. Secretariat-level relationships with partners are also valued and, on 31 December, the GAID secretariat initiated consultations with 21 organizations (see Annex).

Several **Flagship Partnership Initiatives**<sup>8</sup> (**FPIs**) being formed under the umbrella of the Global Alliance are the first set of multi-stakeholder activities catalyzed by GAID to leverage joint resources and to spur visible action toward attaining its objectives across the four GAID focus areas. These are:

Furthermore, the GAID Executive Coordinator addressed audiences to raise awareness of, and promote, GAID and issues related to ICTD at many high-profile events throughout the second half of 2006, including: The Council of Europe's "Human Rights in the Information Society: Empowering Children and Young People," Yerevan, Armenia, 5-6 October 2006; WHO's "The World of Health IT Conference and Exhibition," Geneva, 10-13 October 2006; "The 6th Annual Forum on City Informatization in the Asia-Pacific Region" (CIAPR VI), Shanghai, China, 18-19 October 2006; and Santa Clara University's Centre for Science, Technology, and Society and RIOS Institute's "Silicon Valley Challenge Summit," Santa Clara, California, 16 November 2006.

With the aim of building awareness of the GAID brand, a logo and website template were designed, as well as informational marketing materials. A short video on the Alliance, the Millennium Development Goals and GAID was produced for the launch meeting in Kuala Lumpur. The GAID website (<a href="www.un-gaid.org">www.un-gaid.org</a>) provides background information on GAID and its activities and events. WSIS-online, a powerful portal developed for the Geneva and Tunis phases of the WSIS, was donated to GAID and is in the process of being integrated into the GAID website. In 2007, the site will be integrated with the GAID website, incorporating the relevant databases and interactive aspects to encompass the work of the various networks and initiatives operating under GAID's umbrella.

# (vi) Activities for 2007

Before the end of 2006, the GAID secretariat and its partners had already begun actively preparing for a number of significant events and initiatives scheduled for 2007:

GAID is also committed to co-hosting **UNITAR's Web Seminar Series** on the following topics: "Women and the Information Society" (March); "ICT and Indigenous Issues" (May); "ICT and Youth" (June); and "Open Source Software and Development: Regional Case Studies" (October).

Three **publications** are being compiled and are expected to be unveiled at the Second Meeting of the GAID Strategy Council in Santa Clara in February: the first, a primer on the Global Alliance for ICT and Development, describing its founding, compiling its guiding documents, and providing information on how interested actors can contribute to the attainment of its mission and objectives; the second is a companion publication to the 29 November 2006 special meeting on "Our Common Humanity in the Information Age;" and the third is on *Humanizing the Digital Revolution*, published jointly by GAID, Fordham University and Kadir Has University.

# (vii) Assessment of progress

In 2006, with the intent of laying the foundations for future substantive work, GAID aimed to (1) develop and operationalize an appropriate organizational structure, (2) define its

areas of priority and developed its business plan, (3) build collaborative links and (4) raise awareness of the Alliance.

The Global Alliance for ICT and Development has gone from approval by the Secretary-General (March 2006) to launch (June 2006) to operation in a very short period, thanks to the guidance of the Intel Corporation, the executive direction of the Steering Committee, and the support and contribution of the Strategy Council and other partners. Its governing and advisory bodies are fully functioning, its areas of priority identified, its business plan approved, three Flagship Partnership Initiatives are underway, its regional and stakeholder networks are being formed, as well as its thematic communities of expertise, and its secretariat is already preparing for a full programme of events for 2007.

GAID has succeeded in securing the partnerships of many competent and committed organizations – among them the World Bank, the Swiss Agency for Development Cooperation, Global Knowledge Partnership, the International Development Research Centre and the Malaysian Ministry of Science, Technology and Innovation; and major United Nations agencies and entities – which are leading the networks and initiatives of the Global Alliance. The secretariat is supporting them to develop work programmes and methods to implement in 2007, as well as to bring other competent individuals and organizations into their networks.

Meanwhile, the GAID's name and brand is growing in recognition, due to efforts by the Chair and Executive Coordinator to promote it among high-level contacts throughout the ICT and ICTD communities and at international conferences, as well as to international press coverages. Its website serves as a repository of information for all stakeholders and members of the public, who wish to learn more about the entity and how they can contribute to the Alliance.

Having undertaken this extensive preparation, GAID is now positioned to be a key contributor to the achievement of the outcomes of the World Summit on the Information Society, especially by bringing multi-stakeholder input to the Commission on Science and Technology for Development and the Economic and Social Council. It is also well placed to further the United Nations Development Agenda, which includes the Millennium Development Goals, and to make a meaningful contribution to harnessing the technology-driven WSIS process to support the broader United Nations development goals. To this end, it promotes policy dialogue and action-oriented initiatives through a multi-stakeholder partnership approach. It has already emerged as a spring-board and a major platform for the United Nations system, private sector and civil society partnerships in the strategic areas of education, health, entrepreneurship and governance, serving to advance common goals.
